

# How To Read Your Bill

To read your new bill format, follow the numbers for a guide to your new billing format.

1. Your DCPUD account number.
2. Account Balance Summary shows all charges for your account.
3. Message area.
4. Meter location and meter reading information.
5. This chart compares your monthly usage to the same time last year.
6. Current charges for electric use.
7. Update your account information if necessary.
8. Account number and total due. Return stub with your payment.

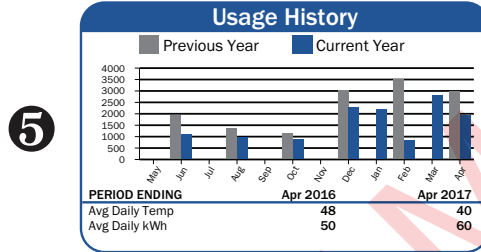
